The application shall be accompanied by:

1. **Payment in full: Sec. 10-52. - Fees.** (a) The annual fee for a sexually oriented business license is \$500.00, or such amount as may be later adopted as part of the city's official fee schedule. This fee is to be used to pay for the cost of the administration and enforcement of this article. (b) Each individual employee shall pay a \$75.00 fee with each application, or such amount as may be later adopted as part of the city's official fee schedule. The individual fee shall not be prorated. (c) Fees are not refundable. *(Ord. No. 636, § II, 4-22-2014)*
2. **If the establishment is a state corporation, a certified copy of the articles of incorporation, together with all amendments thereto;**
3. **If the establishment is a limited partnership formed under the laws of the state, a certified copy of the certificate of limited partnership and the qualification documents, together with all amendments thereto;**
4. **If the establishment is a foreign corporation, a certified copy of the certificate of authority to transact business in the state, the certificate of limited partnership, and the qualification documents, together with all amendments thereto;**
5. **A sketch or diagram showing the configuration of the premises, including a statement of total floor space occupied by the business. The sketch or diagram need not be professionally prepared, but must be drawn to a designated scale or drawn with marked dimensions of the interior of the premises to an accuracy of plus or minus six inches;**
6. **Proof of the current fee ownership of the tract of land on which the establishment is to be situated in the form of a copy of the recorded deed;**
7. **If the persons identified as the fee owner(s) of the tract of land in this subsection are not also the owners of the establishment, then the lease, purchase contract, purchase option contract, leased option contract or other document(s) evidencing the legally enforceable right of the owners or proposed owners of the establishment to have or obtain the use and possession of the tract or portion of the operation of the establishment.**

Items above (1.-7.) shall also be required for a renewal application. A separate application and license is required for each sexually orientated business.
