

# MUNICIPAL COURT OF GRANITE SHOALS

## Payment Schedule Guidelines

The chart below may be used to calculate the fine and court costs you owe on your violation should you decide to enter into a plea of Guilty or No Contest and elect to make payment. If your violation is not listed, you must contact the Court in person or by email to request the Court's assigned fine and court cost. **NO PERSON UNDER THE AGE OF 17 MAY USE THIS FINE AND COURT COST SCHEDULE TO CALCULATE THEIR PUNISHMENT. SUCH INDIVIDUALS MUST APPEAR BEFORE THE COURT IN PERSON ALONG WITH A PARENT OR LEGAL GUARDIAN.**

This chart is a representation of what the Court may consider should you not desire to personally appear in Court and have chosen to plea either Guilty or No Contest by certified mail along with your waiver of a jury trial (see reverse of this document). **NOTE: OFFENSES REGARDING SPEEDING IN A CONSTRUCTION ZONE WITH WORKERS PRESENT WILL DOUBLE THE AMOUNT LISTED BELOW.**

All violations with potential for a dismissal with payment of a fee must have all corrective action taken and payment made prior to the appearance date for the violation. Failure to appear in Court by the appearance date may result in a new criminal case being filed, the issuance of a warrant for arrest, additional costs, and the denial of renewal of driver's license until addressed.

### Violations Requiring Appearance Before Judge

All Juvenile Offenses (under age 17) - must be accompanied by Parent and/or Legal Guardian:

Minor in Possession

Minor in Consumption

All City Code Zoning Violations

Minor Possession Tobacco

All City Code Trash/Dump Violations

Curfew and Fail to Attend School

Speeding 25 mph or more over posted speed limit

### Right of Legal Representation

All persons receiving a citation have the right to consult and/or obtain the services of an attorney to assist in handling the matter before the Court. An attorney may make an appearance on behalf of a client before the Municipal Court. Because this violation involves a class "C" offense where no jail time is prescribed, you cannot request that this Court assign legal counsel to you. You must hire your own attorney should you desire legal representation before this Court.
